Your safety and the safety of all our members, volunteers, and employees is the Jacksonville Clay Target Sports ("Club") top priority. While there is still much uncertainty regarding COVID-19, we are monitoring the information provided by health experts and government agencies to help keep safe those who choose to come the Club for shooting events.

Our Board and Club leaders continue to coordinate with state and local health departments to ensure we are informed of and comply with their guidance to mitigate the risks COVID-19 being contracted at the Club.

Our mitigation plan includes:

- Assuming you have considered your own personal health situation.
- Health screening conducted by you prior to travel to the Club, including a temperature check.
- Wearing a mask and keeping social distance when required. The Club will take your temperature.
 - Note: should anyone not pass the temperature screening, they will not be able to shoot at the Club.
- Hygiene reminders while at the Club.
- Extra hand washing / sanitizer stations throughout the Club.
- Dedicated staff to clean and disinfect high-touch surfaces and shared program equipment.
- An emergency response plan that includes an isolation and quarantine protocol should a person at the Club develop symptoms of COVID-19 or other communicable diseases.
- The use of common sense; if you or anyone is not feeling well, you should not shoot.

These precautions are important, but these efforts cannot eliminate the potential for exposure to COVID-19 or any other illness while at the Club. Experts have said that people with COVID-19 may show no signs or symptoms of illness, but can still spread the virus, and people may be contagious before their symptoms occur. The fact is that someone with COVID-19 may pass the required health screenings and be allowed into the Club.

We also know the very nature of the Club makes social distancing difficult in many situations and impossible in others. Shooters in a cart must wear masks if they do not live in same household.

Information from the <u>Centers for Disease Control and Prevention (CDC)</u> states that older adults and people of any age who have serious underlying medical conditions are at higher risk for severe illness from COVID-19/ <u>If you are in this group, please ensure you have approval from your healthcare provider prior to attending the Club.</u>

Every member, volunteer, and Club guest and family must evaluate their unique circumstances and make an informed decision before attending the Club. We hope this information will be helpful as you make that choice.

HOWEVER – you and members of your group hereby RELEASE AND HOLD HARMLESS, the Club, its employees, officers, directors and any volunteers from any and all liability from contacting the COVID-19 virus (or any other health risk) as a result of your participating in any shooting event at the Club and hereby release them from any responsibility of your having made the decision to attend and engage in any and all activities at the Gun Club.

Their employee members and affiliated organizations for any injury, death or property damage occurring to me as a result of my participation at the Club whether caused by the negligence of the Club or City or any Members otherwise.
- 2. I agree that I and my heirs, guardians, legal representatives and assigns will not make a claim against, sue or prosecute the Club or City for any reason whatsoever, releasing the Club and the City from their own negligence. I agree for myself and my heirs, guardians, legal representatives and assigns that in the event that any claim or Injury, death, property damage or otherwise, shall be brought against the Club or City of Jacksonville or any of its affiliated organizations, I shall indemnify and save harmless said Club and the City for any and all such claims or causes of action by whomever or whatever presented.
